

## EUROPEAN MOUNTAIN RUNNING CHAMPIONSHIPS

### 1101. PROMOTION AND RIGHTS

- 1101.1. The European Athletic Association (hereinafter European Athletics) shall promote a European Mountain Running Championships in every year.
- 1101.2. All rights in and arising from the European Mountain Running Championships are the exclusive property of European Athletics. These rights include but are not limited to rights of ownership, marketing, advertising, broadcasting, filming, televising and all or any other means of exploitation. No other entity may exercise any of these rights without the written consent of European Athletics.

### 1102. PROGRAMME, STRUCTURE AND SCORING

- 1102.1. The European Mountain Running Championships shall be staged on 1 (one) day and in accordance with the applicable Competition, Advertising, Doping and other relevant Rules and Regulations of the International Association of Athletics Federations (IAAF).

- 1102.2. The programme shall comprise the following events for Men and Women:

In even years:

Men:	Uphill and downhill:	Approximately 12 km (750m climbing)
Women:	Uphill and downhill:	Approximately 8 km (500m climbing)

Junior Men:	Uphill and downhill:	Approximately 8 km (500m climbing)
Junior Women:	Uphill and downhill:	Approximately 4 km (250m climbing)

In uneven years:

Men:	Uphill:	Approximately 12 km (1200m climbing)
Women:	Uphill:	Approximately 8 km (800m climbing)

Junior Men:	Uphill:	Approximately 8 km (800m climbing)
Junior Women:	Uphill:	Approximately 4 km (400m climbing)

- 1102.3. The European Mountain Running Championships comprises separate events for teams and individuals representing European Athletics Member Federations.
- 1102.4. All European Athletics Members Federations in good standing shall be entitled to enter athletes in the European Mountain Running Championships.
- 1102.5. Athletes entered in the European Mountain Running Championships may participate as individuals and as members of teams representing European Athletics Member Federations.
- 1102.6. Each European Athletics Member Federation may enter a maximum of 4 (four) athletes in the Senior and Junior Men events and a maximum of 3 (three) athletes in the Junior Women event.
- 1102.7. No athlete aged less than 16 (sixteen) years on 31 December of the year of the competition may participate in the European Mountain Running Championships and no athlete aged less than 18 (eighteen) years on 31 December of the year of the competition may participate in the Senior races.

### **TEAM CHAMPIONSHIP and SCORING**

- 1102.8. There shall be separate team championships for each event.
- 1102.9. Each European Athletics Member Federation may enter 1 (one) team in each event.
- 1102.10. Each team's score shall be determined by the aggregate of the places of its 3 (three) best placed athletes for the Senior and Junior Men events and its 2 (two) best placed athletes for the Junior Women.
- 1102.11. A team with fewer than 3 (three) finishing athletes for Senior and Junior Men events or 2 (two) finishing athletes for Junior Women events shall not be counted in the teams' classification.
- 1102.12. No adjustments to teams' places shall be made in respect of non scoring team members or athletes participating as individuals.
- 1102.13. Teams shall be classified according to their scores, the team in each race having the lowest score being the winner, and so on.
- 1102.14. A tie shall be decided in favour of the team whose last scoring athlete finishes nearest to first place.

### **INDIVIDUAL CHAMPIONSHIP**

- 1102.15. A separate classification of all athletes in each event shall be compiled and the individual championships determined accordingly.

### **1103. ENTRIES AND CONFIRMATION**

- 1103.1. Each European Athletics Member Federation may enter one team or, alternatively, individuals in each event.
- 1103.2.1. No athlete may take part in the European Mountain Running Championships unless entered by the European Athletics Member Federation which he/she is eligible to represent in accordance with the IAAF Rules.
- 1103.2.2. No athlete who, pursuant to IAAF Rule 40, has been declared ineligible to compete for at least 2 (two) years may take part in the edition of the European Mountain Running Championships next following the conclusion of the period of ineligibility.
- 1103.2.3. European Athletics shall inform the suspended athlete in writing of his/her ineligibility according to regulation 1103.2.2 to take part in the next European Mountain Running Championships promptly upon receiving notification of such suspension from the IAAF. Any suspended athlete who is of the opinion that Regulation 1103.2.2 improperly applies to him/her may, within 20 days of being informed by European Athletics, refer the matter to the European Athletics Council. The athlete may appeal against the determination of the European Athletics Council to the Court of Arbitration for Sports (CAS) in accordance with Article 38 par. 1 to 3 of the European Athletics Constitution.
- 1103.3. Preliminary Entries: Not later than 3 (three) months before the date of the European Mountain Running Championships, each European Athletics Member Federation shall send to European Athletics (usually via the teams' on-line entry system) a

preliminary list of entries, indicating its anticipated numbers of athletes per event and the numbers of accompanying officials.

- 1103.4. Final Entries: Not later than 10 (ten) days before the date of the European Mountain Running Championships, each European Athletics Member Federation shall send to European Athletics a final list of its entries, plus the names of accompanying officials. No subsequent changes may be made thereto without the consent of European Athletics. Final Entry information shall be supplied in the manner to be prescribed by European Athletics (usually via the teams' on-line entry system) and shall include such details as required by European Athletics, including the names and best performances of each athlete.
- 1103.5. Final Declarations: Confirmation of Final Entries and the Final Declaration of athletes to compete shall be made according to the procedures defined in the Team Manual.
- 1103.6. European Athletics may reduce financial support (for travel, board/accommodation grants, etc.) to any European Athletics Member Federation which, after having announced its participation, does not take part or attends the competition with a number of athletes and officials materially higher or lower than the number stated in the Preliminary Entry (1103.3 above). The latter applies only if the Preliminary Entry is more than 4 (four).

#### **1104. APPLICATIONS TO STAGE THE EUROPEAN MOUNTAIN RUNNING CHAMPIONSHIPS**

- 1104.1. Any European Athletics Member Federation may apply to stage the European Mountain Running Championships provided that the proposed venue and city comply with the criteria established by European Athletics.

Prior to making the formal application, each potential bidder shall participate in the long term planning by indicating the interest in the annual questionnaire signed by the Member Federation President & General Secretary

European Athletics shall be entitled not to accept any unrealistic announcement or if it was not indicated in the long term planning questionnaire.

- 1104.2. Each applicant shall complete the European Athletics official application forms and supply such information and undertakings as European Athletics shall require. The applications shall be completed in English and any application that is not fully and properly completed may be regarded as invalid.
- 1104.3. The European Athletics Council shall announce the timetables and deadlines for applications and these shall normally include:
- i. Indication of interest in questionnaire of long term planning by 30 November, 3 (three) years before the year of the European Mountain Running Championships which is the deadline to be considered as a candidate for bidding.
  - ii. Confirmation of candidature, with the name of the bid city, to be made by 31 January, 2 (two) years before the year of the European Mountain Running Championships. The candidature form must be signed by the Member Federation and City.
  - iii. Formal application to be submitted within 2 (two) months of ii.
  - iv. Decision of the European Athletics Council within 6 (six) months of ii.

1104.4. The written undertakings required to be submitted with the application shall normally include:

- i. The bidding European Athletics Member Federation's and city's joint undertaking to respect the applicable Rules and Regulations of the IAAF, European Athletics and other competent authorities and to enter into an organising contract with European Athletics.
- ii. A guarantee(s) from the owner(s) that all official sites used for the event, including the competition courses shall be free of all commercial and non commercial advertising, identifications and/or franchises.
- iii. A letter of intent by a television broadcaster of the bidders' country to act as host broadcaster in accordance with the requirements of European Athletics.
- iv. The undertakings in writing of relevant national, regional and other authorities that they support the application.
- v. A detailed budget of income and expenditure for the event.

1104.5. The European Athletics Council shall be entitled to amend or vary the above procedures if it is of the opinion that it is in the interests of the European Mountain Running Championships.

#### **1105. TECHNICAL REQUIREMENTS OF THE VENUE**

1105.1. The European Mountain Running Championships shall be staged in a competition venue and city which are appropriate to the event. European Athletics may establish criteria by which the suitability of a proposed venue may be decided. The city shall be of an appropriate size and standing and the competition venue shall have acceptable facilities and be fully equipped in conformity with the respective IAAF rules.

#### **1106. DOPING CONTROL**

1106.1. Doping control shall be conducted in accordance with the respective IAAF Rules and Guidelines and shall be carried out under the supervision of the European Athletics Doping Control Delegate.

#### **1107. THE ORGANISING CONTRACT**

1107.1 Immediately after the decision of the European Athletics Council to appoint an organiser, the appointed European Athletics Member Federation and city shall enter into an organising contract with European Athletics, such contract to establish the respective rights and obligations of the parties in relation to the European Mountain Running Championships.

#### **1108. THE RIGHTS AND DUTIES OF THE EUROPEAN ATHLETICS**

1108.1. Notwithstanding the organising contract, European Athletics shall retain the overall care and responsibility of the European Mountain Running Championships. In exercise of this role, the European Athletics Council shall:

1108.1.1. Decide the dates, venue and the organiser.

1108.1.2. Appoint Delegates and other persons (see 1111.3).

1108.1.3 Approve the procedure for deciding the timetable of events.

## **1109. THE RESPONSIBILITIES OF THE ORGANISER**

1109.1. The organiser shall be responsible for organising and staging the European Mountain Running Championships in accordance with the organising contract and in compliance with the Rules and Regulations and directions of European Athletics.

## **1110. FINANCIAL REGULATIONS**

### **The Organiser**

1110.1. The financial rights and obligations of the organiser shall be set out in the organising contract. Subject thereto, the organiser shall be responsible for all costs of organising and staging the European Mountain Running Championships but may retain the income from the sale of admission tickets, approved television and marketing rights, subventions and grants from national and/or local authorities.

1110.2. For the avoidance of doubt, the organiser shall be responsible for the costs of the following persons:

Delegates appointed by European Athletics (see 1111.3); (except for the Council Delegate); travel, accommodation and board at the event and accommodation and board at the site visits.

Staff and representatives of European Athletics specialist contractors and sponsors; according to the respective contracts.

### **European Athletics**

1110.3. European Athletics shall not be responsible for any costs other than those referred to in these regulations and/or the organising contract.

1110.4. European Athletics - unless otherwise agreed- shall bear the board and lodging expenses at the venue of the competition for a maximum period of not more than 2 (two) days and for a maximum number of the scoring athletes in each event: up to 3 (three) Men and 3 (three) Women athletes in Senior events and up to 3 (three) Men and 2 (two) Women athletes in Junior events per visiting team.

1110.5. European Athletics shall be responsible for all direct laboratory costs connected with the doping control including laboratory costs but excluding tests specifically requested by Member Federations.

1110.6. European Athletics shall be responsible for the travelling costs of Delegates appointed by European Athletics at the sites visits prior to the event and staff members travelling costs, accommodation and board when visiting the venue.

### **The Participating European Athletics Member Federations**

1110.7. European Athletics Member Federations shall be responsible for all costs (including travelling to and from the venue) incurred as a result of their participation in the

European Mountain Running Championships which exceed any contributions made by the organiser in accordance with 1110.4 above.

- 1110.8. The final account for accommodation attributable to each Member Federation shall be based on the numbers declared in the Final Entries and this shall be paid in full, no allowance being made for subsequent any reduction in the actual numbers of athletes and/or officials.
- 1110.9. European Athletics Member Federations are responsible for taking out their own insurance to cover illness or injury to any member of their party when travelling to and from and during the European Mountain Running Championships.

#### **1111. THE EUROPEAN ATHLETICS OFFICIATING PERSONS**

- 1111.1. The President, the Treasurer and Director General of European Athletics or their representative(s) shall have the overall responsibility for the care and supervision of the European Mountain Running Championships.
- 1111.2. European Athletics shall designate a member of its professional staff to be the Project Leader having the responsibility to coordinate the European Athletics Officiating Persons and other staff members and to direct the operational management of the event in cooperation with the organiser.
- 1111.3. The European Athletics Council shall appoint the following Delegates and other persons to provide specialist advice and guidance to the organiser:
- 1 Council Delegate;
  - 1 Technical Delegate;
  - 1 Doping Control Delegate;
  - 3 Jury of Appeal Members (together with a fourth replacement to be appointed at the Technical Meeting).
- 1111.4. As soon as possible after the decision to appoint an organiser European Athletics shall inform the organiser as to the names and roles of the European Athletics Officiating Persons and the organiser shall cooperate with and follow the reasonable and proper directions of such persons.

#### **1112. PROTOCOL, CEREMONIES, AWARDS**

- 1112.1. All matters concerning protocol, ceremonies, awards and related matters shall be decided by European Athletics which may, from time to time, establish guidelines.

##### **Opening and Closing Ceremonies:**

- 1112.2. Subject to 1112.1, the organiser shall propose opening and closing ceremonies of styles and content appropriate to the venue. These may include ceremonies and/or celebrations held either inside or outside the competition venue. Such proposals shall be subject to the approval of European Athletics and shall be appropriate to a European Mountain Running Championships.

**1112.3. Victory Ceremonies:**

1112.3.1. The individual winner, second placed and third placed shall receive gold, silver and bronze medals respectively.

1112.3.2. The winning team in each event shall receive and retain a cup to be provided by European Athletics. The second and third teams shall receive a trophy to be provided by European Athletics.

1112.3.3. For the winning, second and third teams, the 3 (three) scoring members as well as non scoring members who completed the event shall attend the ceremony and receive medals.

1112.3.4. During the ceremony, the national anthem of the winner's country shall be played.

1112.3.5. During the ceremony, the athletes must wear their official team uniforms.

**Diplomas:**

1112.4. Diplomas (to be provided by the organiser) shall be presented to the first 8 (eight) placed athletes and teams in each event but no ceremonies will be held.

**Commemorative Souvenirs:**

1112.5. The organiser shall present all participating athletes and officials with a suitable commemorative souvenir.

**1113. INFORMATION, NAMES AND ABBREVIATIONS**

1113.1. All information shall be printed, displayed or announced in English.

1113.2. The names and abbreviations of all European Athletics Member Federations shall, at all times, conform to those approved and decided by the IAAF.

**1114. FINAL PROVISIONS**

1114.1. All matters not provided for by these Regulations shall be decided by the European Athletics Council.

1114.2. These Regulations are drawn up in English.

1114.3. These Regulations may be amended by the European Athletics Council.
